Each category of MII Institutional Member consists of different entry requirements and all employees of the MII Institutional Member will automatically be recognized as MII Affiliates (Institution). Please refer to the details provided below:

Category	Minimum Requirement	Annual Subscription Fee
Company	All insurance institutions registered or licensed under the Financial Services Act 2013 or regulated by the Labuan Financial Services Authority.	RM 25 per staff
Educational	Institutions of Higher Learning, Colleges, Vocational Schools and other institutions recognized by the Ministry of Education (MOE) or Ministry of Higher Education (MOHE).	RM 100
Others (Local)	Other institutions and organizations operating in an insurance related field or in the financial services sector in Malaysia.	RM 500
Others (International)	Other institutions and organizations operating in an insurance related field or in the financial services sector outside Malaysia.	USD 150

NOTE: An upgrade fee of RM100 is applicable for all employees of Institutional Members who wish to upgrade their Affiliate level membership to Individual level membership.

Employees of an Institutional Member 'Company' may receives a discounted annual subscription rate if they upgrade membership. This would not be applicable if the company is not active during the upgrade.
